The RAFI™ Multi-Factor index series offers diversified factor exposures through allocations to value, low volatility, quality, momentum, and size. The Dynamic Multi-Factor strategy takes time-varying exposures to the same five factors. The index uses recent and historical metrics to tilt toward factor portfolios which are particularly attractive on a forward looking basis.

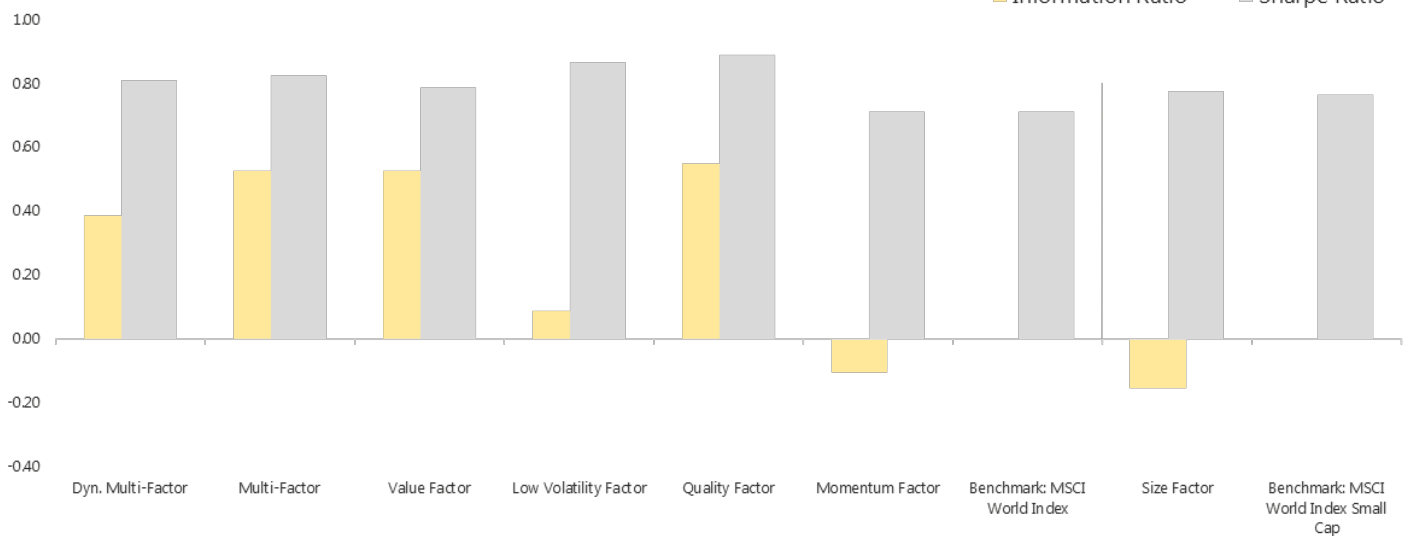

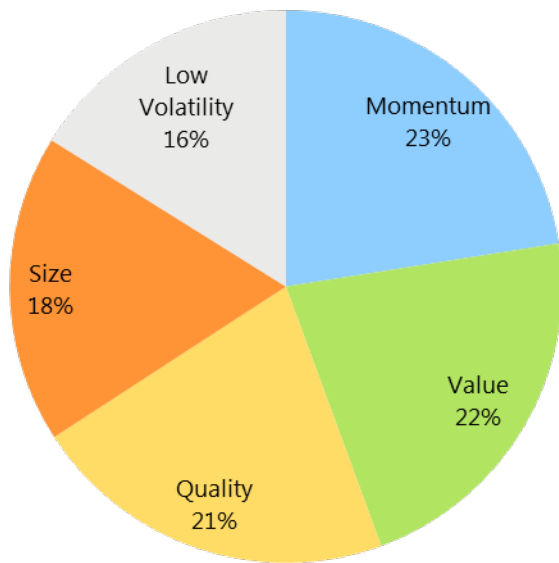

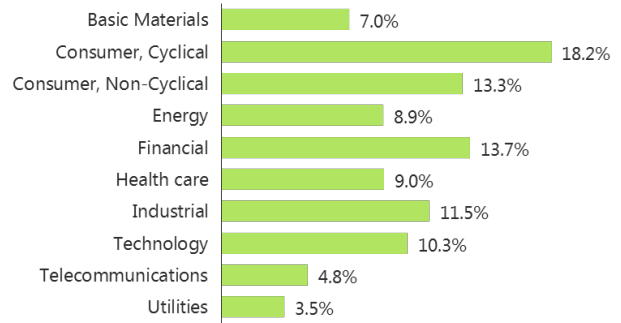

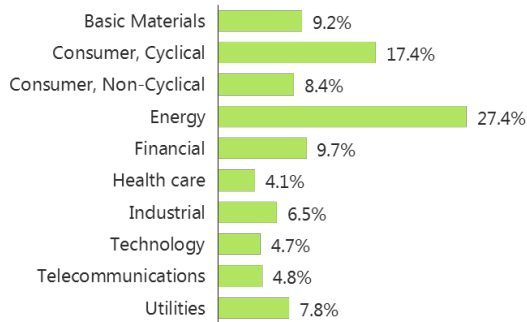
RAFI Dynamic Multi-Factor Developed Index



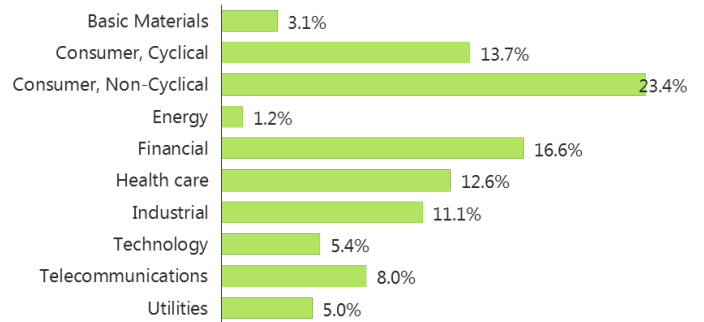
RAFI Multi-Factor Developed Index



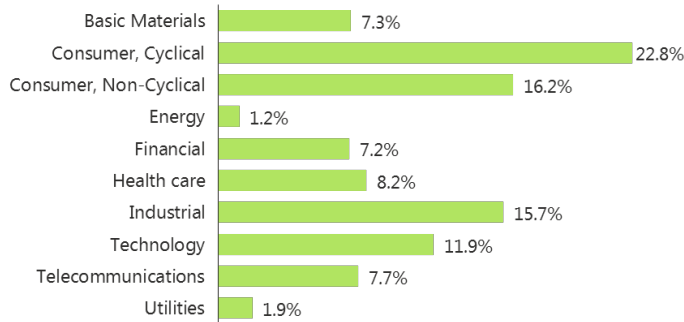
RAFI Value Factor Developed Index



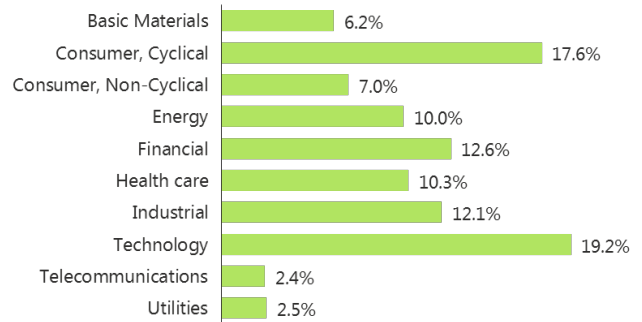
RAFI Low Volatility Factor Developed Index



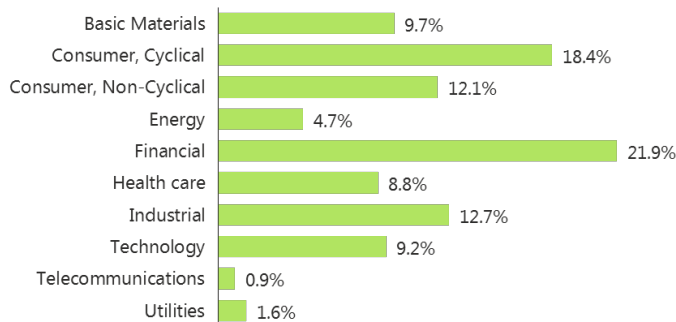
RAFI Quality Factor Developed Index



RAFI Momentum Factor Developed Index

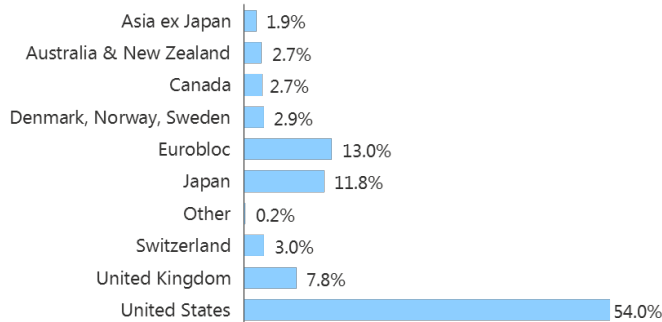


RAFI Size Factor Developed Index

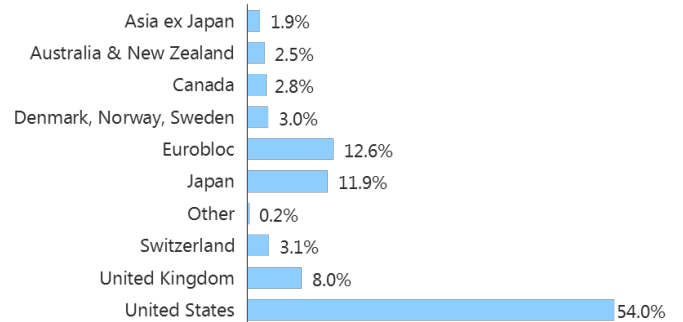

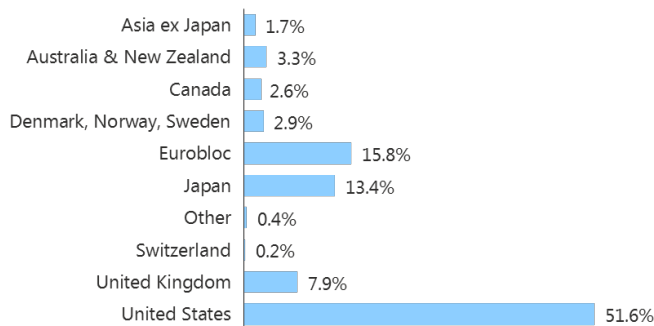

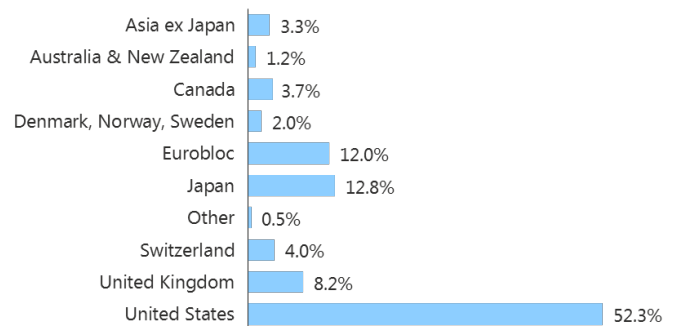
RAFI Multi-Factor Developed Index



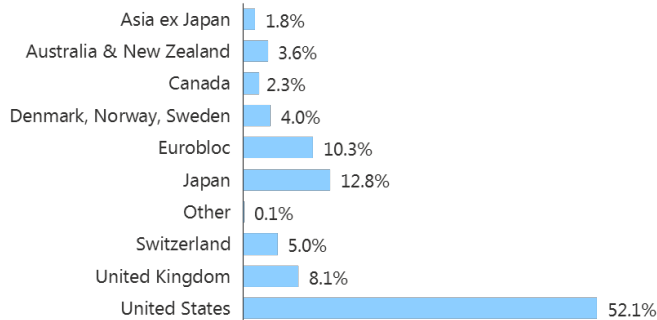
RAFI Value Factor Developed Index



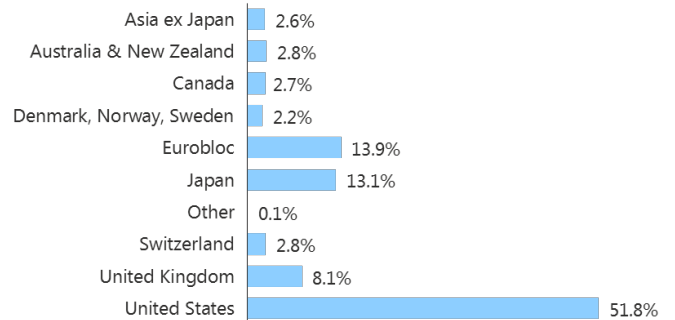
RAFI Low Volatility Factor Developed Index



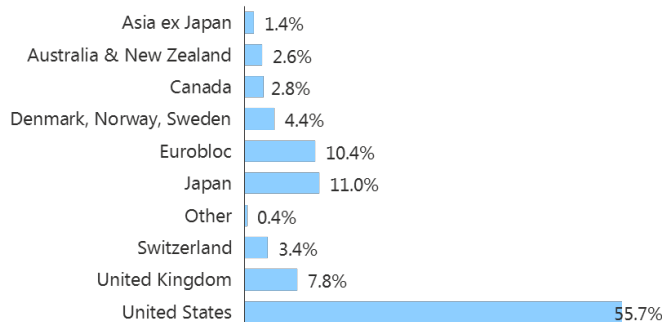
RAFI Quality Factor Developed Index
